EVIDENCE OF IDENTITY (Originals)

- A current valid passport.
 - A current valid driving licence with a photograph.
 - A current National Identity Card.

PROOF OF PPS NUMBER – any one of the following

- Official Revenue/Department of Social Protection Document
 - European Health Insurance Card
 - Drugs Payment Scheme Card/Medical Card/GP Visit Card

EVIDENCE OF ADDRESS (Originals dated within last 6 months) – any one of the following

- A recent utility/household bill: Electricity/ Gas, Waste Collection
- Letter or Statement from Financial Institution

You are also expected to provide:

- Resolution of Board of Directors to open Business Account.
 - Mandate outlining Signatories to Account
 - Company's Memorandum of Association, Articles of Association and Certificate of Incorporation, as well as evidence of the Registration of Business name.
 - Most recent Audited Accounts and six months bank statements (if available).

COMPANY DETAILS

- Name, Address and Company Type
- Copy of Partnership Agreement (if applicable)
- Evidence of registration of Business name (if applicable)
- Details of Beneficial owners
- Most recent Audited Accounts and six months bank statements

The Directors/Business owners will also be required to confirm the following;

- Purpose of the account
- Source of funding for the account
- Estimated annual turn-over of the account
- All signatures to the account must also be provided
